*Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.*

The goods and services shown below are those we can provide to our customers. You may choose only those items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements indicate that you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

**BASIC SERVICES OF THE FUNERAL DIRECTOR AND STAFF:** \$1,295.00

Our services include conducting the arrangement conference, planning the funeral, consulting with family and clergy, shelter of remains, preparing and filing of necessary notices; obtaining necessary authorizations and permits, statistical processing, coordinating with the cemetery, crematory, or other third parties. In addition, this fee includes a proportionate share of our basic overhead.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremation, immediate burials and forwarding or receiving remains)

**PROFESSIONAL EMBALMING:** \$695.00

Embalming is not required by law; However, in certain special cases, embalming may be necessary if you select funeral arrangements with viewing. Should you choose not to accept embalming, you have the right to choose an arrangement that does not require it; therefore, you do not pay for it. Such examples would be direct cremation or immediate burial.

**Refrigeration** \$ 95.00/day

*California law requires refrigeration of unembalmed remains after 24 hours*

*(Our services include set-up of visitation area, placement of encased remains, display of floral arrangements, supervision of and attendance during the visitation.)*

Use of Equipment and Staff for Funeral Ceremony \$425.00  
*(Our services include coordinating the funeral arrangements, supervision of the funeral service, display of floral arrangements and Staff to assist with the funeral ceremony.)*

For Memorial Service (*without remains present*). \$375.00  
*(Our services include coordinating the memorial service arrangements, supervision of the memorial service, display of floral arrangements and staff to assist with the service.)*

Use of Equipment and Staff for Graveside Service. \$375.00  
*(Our services include accompaniment of remains to cemetery, supervision of graveside service, display of floral arrangements and staff to assist with the service).*

Use of Equipment and Staff for Rosary, Wake or Evening Service. \$425.00

Additional charge for Use of equipment and Staff on weekends & holidays. \$350.00

**TRANSPORTATION :**

Transfer of deceased from place of death into our care (w/in 50 mile radius) \$595.00

Funeral vehicle (Hearse) (within 50 mile radius) \$255.00

Service Vehicle (Utility/Flower Van) (within 50 mile radius) \$175.00

Limousine (within 50 mile radius) \$450.00

Transfer to or from airport. \$550.00

**\*\* Additional distance will be charged at \$ 3.95 per mile.**

**FORWARDING OF REMAINS TO ANOTHER FUNERAL HOME :** \$1,595.00

This charge includes removal of remains from place of death, minimum services of staff, necessary authorizations, embalming, use or preparation room and local transportation (excluding shipping charges and shipping container). This charge does not include use of facilities and staff for visitation or ceremonies.

**RECEIVING REMAINS FROM ANOTHER FUNERAL HOME :** \$ 1,595.00

This charge includes minimum services of staff, transportation from airport, transportation of remains to cemetery or crematory. This charge does not include visitation of ceremonies.

**DIRECT CREMATIONS :** \$ 1,090.00

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and are made of cardboard (without an outside covering).

Our charge for direct cremations (without ceremony) include : *Removal of remains, transportation to crematory, refrigeration and minimum services of Staff. Cremation Fee is included.*

Direct cremation with container provided by the purchaser (all such containers must meet any applicable State or crematory requirements). \$ 1,090.00

Direct cremation with casket purchased from our funeral home (in addition to cost of casket) range in price from \$1,590 to \$4,595

**IMMEDIATE BURIAL:** \$ 1,095.00

Our charge for immediate burial (without any rites or ceremonies at the funeral home, graveside or elsewhere) include: *Removal of remains, transportation to cemetery and minimum services of staff.*

1. Immediate burial with container provided by the purchaser (all such containers must meet any applicable State or cemetery requirements). \$ 1,095.00
2. Immediate burial with minimum casket. \$ 1,890.00

## DISCLAIMERS

### FUNERAL ESTABLISHMENT RESPONSIBILITY

Business and Professional Code Section 7745 requires a funeral establishment to present to the survivor of the deceased or the responsible party a copy of any pre-need agreement in its possession which has been signed and paid for in full or in part by, or on behalf of the deceased.

Business and Professional Code Section 7685.6 requires a copy of any pre-need agreement to be disclosed prior to drafting any contract for funeral goods or services. The funeral establishment may present the copy in person, by certified mail, by fax transmission, or by email as agreed upon by the person with the right to control disposition. A funeral establishment that knowingly fails to present a pre-need agreement as required is liable of a civil fine equal to three times the cost of the pre-need arrangement or (one thousand (\$1,000.00) dollars).
